Chairman Cooney advised that telephones would be muted except for portions of the agenda for public comments.

Prayer was read by Committeeman Conklin.

2020 Municipal Budget:

1. Resolution #2020-150 waiver of reading in full of the 2020 Municipal Budget

- a) be posted in a public place where public notices are customarily posted and at the free public library, and
- b) is made available to each person requesting the same during said week and during the public hearing, and

WHEREAS, the Township of Montville has complied with the aforesaid requirements.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee, the reading in full of the 2020 Budget be dispensed with.

2. Public hearing on the 2020 Municipal Budget

Motion by Cook second by Kayne to open pubic hearing on the 2020 Municipal Budget. All in favor. Motion adopted.

Administrator Victor Canning gave a recap of the 2020 Municipal Budget:

- Tax levy is 1.44% increase, approximately a \$30 increase on the average assessed home (about \$2.50 per month). This is the 3rd lowest increase in the last two decades.
- \$300,000 in cuts were made to the budget to lighten the taxpayer load without impacting the quality of Township services.

4. Resolution #2020-152 Self-Examination of the 2020 Township Budget.

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination, and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997, and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 thru 7.5 the Township of Montville has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2020 budget year.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Montville that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the Township Committee has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget.
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4- 45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with the "CAP" law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate, and correctly stated;
 - b. Items of appropriations are properly set forth
 - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED, that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

COVID-19 is improving with no new cases for 3 days and 2 cleared cases. Township total
was 23 people. Public should still observe shelter-at-home and social distancing. Police Chief
Andrew Caggiano is working on the FEMA application to recoup Township expenses due to
the COVID19 responsive measures.

- Supreme Court denied application of JCP&L appeal. The Township's settlement will go forward.

- 3. Township Committee liaison reports and comments

Chairman Cooney -

Chairman Cooney read the following statement regarding Executive Order 130:

"On April 28, 2020, the date Executive Order 130 was provided to the Township, many residents had already paid their property taxes and the majority of the outstanding balance for the quarter was due from the banks, financial institutions, and mortgage companies who pay property taxes on behalf of the homeowner. The Governor did not extend the Town's obligation to pay the Board of Education and the County of Morris. So, the obligation for the Township to pay the County and School are still in place, since the State failed to extend such due dates. A late payment to the County would result in a 6% penalty.

Every Town needed to review their cash flow to be certain that an extension will not cause a shortfall in cash and the Township will be able to meet its statutory obligations. Now that we have the funds from the mortgage companies, financial institutions, and banks, we can offer this courtesy to our residents who are financially struggling as a result of this pandemic. This extension is the maximum extension permitted by law, an extension to June 1. We are pleased to take this action knowing that the Township is still able to meet all of its financial obligations."

He stated that Resolution #2020-162 would be added to the agenda

Committeewoman Witty

- Drug Awareness Council Municipal Alliance (DAC) is still selling lawn signs for graduates of Middle School and High School. Information is on the DAC webpage.
- V.F.W. has requested a banner to be hung across Changebridge Road in observance of Flag Day. The V.F.W. asked Mrs. Witty to present another matter for closed session.

No reports from Committeeman Kayne, Deputy Mayor Cook or Committeeman Conklin.

Old Business:

1. Project status report

Committeeman Kayne asked whether the meeting with Parsippany-Troy Hills Township about sewerage was still taking place on May 14.

Assistant Administrator June Hercek confirmed the meeting was still going forward.

Committeeman Kayne also stated that he was pleased to see modifications from the Township Engineer on the proposed road ordinance and looks forward to proceeding.

New Business:

Montville Township Senior Class support.

Committeeman Kayne stated that the Board of Education is meeting this evening to discuss graduation and year end activities based on guidelines under the COVID19 State of Emergency.

Assistant Administrator June Hercek commented that a May 9, 2020 letter from the Department of Education enumerated certain restrictions from the State Director of Emergency Management such as no in-person ceremonies, graduations, proms, wave parades, parades, etc. These would violate Executive Order 107 and should be postponed or cancelled until such times as these restrictions are lifted.

The Township Committee agreed to seek more information on what the Board of Education plans before formalizing support.

<u>Henry Bernstein, 12 Breton Drive</u>: He asked about Township plans for any resurgence of COVID19 infection in light of the approaching cold and flu season in the fall. He also asked what the Township will do to enforce continued guidelines.

Administrator Victor Canning responded that the Governor's office released additional executive order directives. There will criteria for testing and other measures such as contact investigations to forecast the future. Administration and Township Department Heads are in discussion about Township events contingent on emergent details.

Administrator Victor Canning stated that Health Officer Amy Puluso is reviewing directives and will draft specific measures regarding the Township's enforcement of executive orders from the State.

6. Resolution #2020-161 resolution authorizing the Tax Collector to process third quarter "estimated" Tax Bills, due August 1, 2020

WHEREAS, in light of the disruption caused by the coronavirus outbreak, the State delayed the adoption of the State Fiscal Year 2021 Budget to September 30, 3030; and

WHEREAS, the DLGS "srtrongly recommends" under Local Finance Notice 2020-07 "that Municipalities prepare to issue estimated property tax bills for 2020" and

WHEREAS, the Division of Local Government Services DLGS) may not certify State Aid allocations until State Aid Appropriations are known; and

WHEREAS, without a 2020 Certified Tax Rate, the Tax Collector cannot process the final 2020 Tax Levy; and

WHEREAS, the Tax Collector, in consultation with the Chief Financial Officer, computed and certified an estimated Tax Levy necessary to bill the third quarter taxes due August 1, 2020

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the township of Montville, in the County of Morris and State of New Jersey, hereby authorizes that:

- The Tax Collector is directed to prepare and issue estimated tax bills for the Township of Montville for the third quarter of 2020, in accordance with the provisions of N.J.S.A. 54:4-66.2 et seq.
- The entire estimated tax levy for 2020 is hereby set at \$111,653,671.
- The Tax Collector takes any additional steps necessary to immediately implement this resolution

BE IT FURTHER RESOLVED that, the third quarterly installment of 2020 taxes shall not be subject to interest until the later of August 10, 2020 or the twenty-fifth (25) calendar day after the date the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.

 Resolution #2020-162 resolution instituting a grace period through June 1, 2020 for payment of second-quarter property taxes due May 1, 2020, pursuant to Executive Order 130

WHEREAS, pursuant to N.J.S.A. 54:4-66(a), second-quarter property taxes in the Township of Montville are due May 1, 2020, with a ten (10) day statutory grace period; and

WHEREAS, on April 28, 2020, in response to New Jersey's ongoing COVID-19 Public Health Emergency and State of Emergency, Governor Phil Murphy signed Executive Order 130, which authorizes municipalities to institute by resolution a grace period concluding on a date no later than June 1, 2020 for the payment of second-quarter property taxes due May 1, 2020; and

WHEREAS, while the Township must still meet its continuing financial payment obligations to the County of Morris and local board of education, the Administration has taken the necessary financial steps to accommodate the extension of the second-quarter payment to June 1, 2020, the latest date permitted by law; and

WHEREAS, the Township has reached the statutory ten (10) day grace period and now wishes to extend the grace period to June 1, 2020 to provide relief to those taxpayers who may be suffering from financial hardship related to the COVID-19 pandemic, such as a substantial loss of income and additional expenses for necessary healthcare.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Committee of the Township of Montville, in the County of Morris and State of New Jersey, as follows:

- 1. In accordance with Executive Order 130, the Township of Montville hereby institutes a grace period through June 1, 2020 for the payment of second-quarter property taxes.
- 2. In the event taxes are not paid by June 1, 2020, the Township is obligated to assess applicable interest and penalties as set forth by law.
- 3. This Resolution is retroactive to May 11, 2020, when the statutory grace period ended.
- 4. The Township Clerk shall notify the Director of the Division of Local Government Services in the Department of Community Affairs of this Resolution no later than the third business day following its adoption.

This Resolution shall take effect immediately.
