#### **MINUTES**

Motion made by Commissioner Van Koppen to approve the June 29, 2020 minutes, seconded by Commissioner Moscone, all in favor by voice vote.

#### **CORRESPONDENCE:**

A letter and drawing was received from Kiwanis requesting support of their interest to build a memorial wall and the placement of a plaque and flagpole in Community Park in the grass area below the Pavilion that abuts to the wetland area. The Recreation Commission are in favor of sending this recommendation to the Township Committee.

## **DIRECTORS REPORT:**

The Concerts in the Park Series is having a great turnout. Approximately 200 people per concert. There has been no problem with social distancing.

Programs that are running are going well and there have been no reports of problems. More outdoor programs have been added.

#### **OLD BUSINESS**

Chairman Driscoll asked when the basketball improvement project was to start. Director Dent stated the project would start 8/31 when the summer basketball camps conclude. The project should take two weeks and the courts should open to the public in mid-September.

New grills and picnic tables have been installed at the Amphitheater Pavilion. The fence improvements have been completed at Camp Dawson. Community Park Fields 3 & 4 have been re-lamped.

Community Park Turf Netting along Changebridge Road has been temporarily repaired. However a more extensive improvement required along Changebridge Road and the new parking lot end requires Capital funding consideration in 2021.

MBSA - Liaison Kirschner stated that a summer league took place with no problems. There will be a few teams for a fall program.

BRONCOS – Liaison Matarazzo stated that field usage forms have been submitted. He is reviewing the list of coaches to see if anyone needs to be recertified. Season has been pushed back with a practice start date of September 1 and a game start date of October 3rd. There will be a 5 game season. There will not be a snack stand open for the 2 home games. Thermometers have been purchased. There are currently 105 kids registered for this season.
