RESOLUTION OF THE MONTVILLE TOWNSHIP BOARD OF HEALTH, COUNTY OF MORRIS AND STATE OF NEW JERSEY, ESTABLISHING MEETING SCHEDULES FOR THE MONTVILLE TOWNSHIP BOARD OF HEALTH DURING 2020.

WHEREAS, the Open Public Meetings Act, R.S. 10:4-6 requires that public bodies provide adequate notice of meetings;

BE IT THEREFORE RESOLVED, by the Montville Township Board of Health, in the County of Morris, State of New Jersey as follows:

2. Certified copies of this Resolution shall be:
 - a. Mailed to the Daily Record;
 - b. Filed with the Montville Township Clerk;
 - c. Filed with the Secretary of the Montville Township Board of Health;
 - d. Posted on the bulletin board in the lobby of the Township Municipal Building;
 - e. Mailed to any person requesting notices of meetings of the Montville Township Board of Health pursuant to R.S. 10:4-19 who has paid the required fee thereof.

The foregoing shall be accomplished within seven (7) days of the adoption of this Resolution.

3. In the event that the foregoing schedule of regular meetings of the Montville Township Board of Health is hereafter revised, the Secretary of the Montville Township Board of Health is hereby directed to, within seven (7) days following such revisions, mail, file, and post notice thereof in the manner as provided herein with respect to this Resolution.

This Resolution shall take effect immediately.
